ORDER

- 1) As per the paper read as (2) above the resolution of the XVIII meeting of Academic Council held on 08/01/2015, granting recognition to off Campus Degrees of Bharathiar University, Tamilnadu & Madurai Kamaraj University, Tamilnadu to those students who have registered till 30th Nov 2010 and acquired Degree during the respective period of the course within the consecutive years of the Courses has been implemented and added a clause that above benefit is limited only to Programmes/Courses/Degrees of Bharathiar University & Madurai Kamaraj University which have already been recognized/equated by this University. As per the paper read as (3) benefit of the above resolution of the Academic Council has been extended to all the courses which have been already recognized by this University in respect of other State Universities as well.
- 2) The XIX meeting of the Academic Council held on 22-03-2016, as per the item No: II 5 of the paper read as (1) above, has considered the question of waiving the clause in para 2 (ii) of the U.O. read as paper (2) above that the Degree be acquired during the respective period of the course and within consecutive years and resolved to waive the clause.
- 3) The XIX meeting of the Academic Council held on 22-03-2016, as per the item No: II 7 of the paper read as (1) above, has also resolved to consider the matter of recognition of Distance Education Degrees of Kannur University as equivalent to the corresponding Regular Degrees of Kannur University.
- 4) After considering the matter in detail the Vice Chancellor has been pleased to implement the resolutions of XIX meeting of the Academic Council and issued orders as follows.

- i) To issue Equivalence/Recognition Certificates to those students who have registered till 30th Nov 2010 for Off Campus courses/Programmes of other state Universities, if the course offered through Distance Education mode of study of the concerned University and the same has already been recognized by the Kannur University.
- ii) To recognize the Distance Education Degrees of Kannur University as equivalent to the corresponding Regular Degrees of Kannur University.

ORDER

1.As per the reference read first above, the Academic Council of this University, at its meeting held on 31-12-02 resolved to constitute the Equivalence Committee to deal with the cases of recognition of Degrees/Diplomas/Courses of other Universities/ Boards/Institutions.

2.The Equivalence Committee at its 27th meeting, held on 02/11/2010, vide reference read second above, considered the question of recognition of Degrees of other Universities and resolved to recognize the following Degrees awarded by the specified Universities as detailed below.

3.	Keltron Tool room Research and Training Centre(KELTRAC) Aroor	Diploma in Tool and Die making (Regular)	--	Recognized as sufficient qualification for admission to B.Tech course in Mechanical Engineering through lateral entry.

3. The 27th Equivalence Committee also resolved to implement the following decisions.

- i) Decided to recognize the regular B.E Degrees awarded by the Statutory Universities approved by the AICTE as equivalent to B.Tech Degree of this University.

- ii) While considering the UGC's letter NO.F.9-8/08(CCP-1) dated 28-04-2009 on territorial jurisdiction of the State Universities/State private Universities, Equivalence Committee resolved that the applications for recognition of courses of other state Universities be processed only after producing under taking from the Registrar of the concerned University to the effect that the contact programme and examination of the said courses was conducted within its territorial jurisdiction as per rules of DEC/UGC. In fresh applications for recognition such an under taking should be produced along with the attested copies of scheme and syllabus of the course sought to be recognized.

4. After considering the recommendations of the Equivalence Committee, sanction has been accorded by the Vice-Chancellor to recognize the said Degrees awarded by the said Universities and Institutions detailed above and also accorded sanction for implementing the decision of Equivalence Committee detailed in para 3 above.
